





On the other hand, subsidiary intermediaries are assigned to their principal intermediary's frontline regulator and some subsidiary intermediaries may be attached to more than one principal intermediaries that were not attached to any principal intermediary outnumbered subsidiary intermediaries that were attached to more than one principal intermediary, the number of subsidiary intermediaries was larger than the total of subsidiary intermediaries by frontline regulator.



Chart II.4.2 Investment of constituent funds*: deposits and cash by currency breakdown – 30 September 2024





圖 II.4.3 按貨幣劃分投資於債務證券的成分基金資產分配 * - 2024 年 9 月 30 日

Chart II.4.4 Investment of constituent funds*: equities by geographical region¹ – 30 September 2024





圖 II.4.5 按基金種類及資產類別劃分的成分基金資產分配 * - 2024 年 9 月 30 日

The net rate of return of the MPF System was calculated by way of the internal rate of return (IRR), a method commonly known as dollar-weighted return. The IRR method, which takes into account the amount and timing of contributions into and benefits withdrawn from the MPF System, was used as it better reflects the features of cash inflow and outflow of the MPF System. The annualized net rate of return of the MPF System since its inception was 3.0%, compared with an annualized inflation rate of 1.8% in the same period.








圖 II.6.2 按基金種類劃分投資於「預設投資」成分基金的強積金 總資產*
